PRIVACY POLICY

The EU General Data Protection Regulation (GDPR) came into effect on Friday 25th May 2018. In order to comply with the requirements of this legislation and ensure that we could still communicate effectively with our members, we implemented a new Privacy Policy on this date. The Policy provides details on how the Station Masters GC protects your personal information, and your rights in relation to this. We are committed to protecting our member's privacy and the security of the information that personally identifies you.

Information we collect from you

The Station Masters GC collects personal information from you in accordance with the 'Invitation to Join' form you completed when applying to join the Club, i.e., Gender, Name, Address, Telephone No., e-mail address, DOB, handicap, membership of other clubs and CDH Lifetime ID.

How we use this information

The Station Masters GC requires this information in order that we can manage your Club Membership. We use this information to:

- a Send you e-mail communications from the Club e-mail account stationmasters@live.co.uk about a range of topics including memberships, competitions and rules and regulations.
- b Set-up and administer your account with our WHS/CDH provider, Scottish Golf VMS. This enables us to administer the system as required in order that your WHS Handicap Index is maintained.
- c Your membership of the Station masters GC automatically provides you with membership of Scottish Golf (SG) and Angus County Golf Association (ACGA).

If you are using the Scottish Golf App you have already signed-up to the Terms and Conditions contained in the 'End User License Agreement'. Who we share your personal information with

The Station Masters GC share your information with Scottish Golf in order that your WHS HI can be administered. We will never share your personal information with any other third party without your express consent.

Player's personal data

We publish the results of various competitions e.g., weekly sweepies, monthly medals etc on our WordPress website *thestationmasters.com* including player's names and handicaps.

Member's names, photographs, videos etc may appear on our website from time to time for information and entertainment purpose.

Any cookies on our website are used to ensure normal website functions and cannot be switched off as the website would not function properly without them. However, it is our understanding that these identifiers do not store any personal data.

When you leave a 'comment' on our blog, WordPress will automatically store your gravatar name, IP address, comment, and e-mail address. Therefore, leaving a comment is considered a 'definite intention' as defined by GDPR, giving us consent to store this information and permission to contact you in the future. Please rest assured however, that your personal information will not be sold or shared with any third parties under any circumstances. If for any reason you do not consent to the foregoing, please do not leave any comments on our blog.

If they so wish, members can enable the 'Contact' function on the Scottish Golf app. This gives members access to other member's mobile telephone and e-mail contact details and is particularly helpful for arranging competition ties etc. If you enable the function this is considered a 'definite intention' as defined by GDPR and you consent to your contact details being accessible to other members who have also enabled the function. If you do not consent to this, please do not enable the 'Contact' function on the Scottish Golf app.

How we protect your personal information

Member's personal details are stored on the Scottish Golf Venue Management System which is accessed by the Club Secretary and the Handicap Sub-Committee for the purposes previously stated. Member's details are also stored on the Club's computerised database to facilitate annual membership renewals.

How long we keep your personal details.

The Station Masters GC will only keep your personal details for as long as is necessary to provide you with membership services. If you leave the Club, your details will be deleted.

Your rights in relation to your personal information

- i. You have the right to request access to the personal information we hold about you.
- ii. If you believe that any of your personal information is inaccurate, you have the right to request we correct it.
- iii. You have the right to request that we restrict the processing of your personal information for specific purposes.
- iv. If you wish us to delete your personal information you may request that we do so.
